The meeting was called to order at 7:00 p.m. by President Schaecher.

Minutes

Motion made by Susan Thomas, seconded by Kali Keenum to approve the minutes from the April 17, 2023 meeting. A voice vote was taken with an affirmative result, and the motion carries.

Election of officers (Section 140.080)

Chairman Schaecher stated we needed to open the floor for nominates of president and vice-president.

- a. President – Kalie Keenum nominated Ryan Schaecher for president, seconded by Susan Thomas. Ryan Schaecher accepted the nomination. There were no other nominations for this position. A voice vote was taken with an affirmative result. Opposed: none. Abstain: none.
- b. Vice-president – Susan Thomas nominated Kalie Keenum as vice-president, seconded by Ryan Schaecher. Kalie Keenum accepted the nomination. There were no other nominates for this position. A voice vote was taken with an affirmative result. Opposed: none. Abstain: none.

New Business

- a. PSA Seasonal rental application

President Schaecher stated this was in the packet. Administrator Roth stated all he had was the application with fields 1,2 and 3 and the fee is \$ 300 per field. President Schaecher stated in years past they did maintenance in lieu of the rental fees. He asked if anybody else heard from them. He continued that generally they request a waiver of the fees. Administrator Roth stated he had nothing further. Susan Thomas asked if it was typical for them to approve these types of applications. President Schaecher stated typically it is only if they request a waiver. Administrator Roth stated there is no contract, but they would have an insurance requirement. The use of the concession stand is not spelled out in the code, but they have used it in the past. Superintendent Fowler stated they are storing items in there. Administrator Roth stated that will have to be addressed. The application could be changed by city staff, if there is a fee change then that would go to the Board. ***A recommendation was made by Susan Thomas to review the field rental application to include verbiage regarding renting the concession stand for a fee. Discussion followed. Susan Thomas retracted this statement, until they do further review and set a fee that is appropriate. This will be discussed further at the next meeting.*** Administrator Roth stated St. Bridget's has interest in field 5 (south field) and also Crosspoint Christian School has asked about and currently field 5 is available. Superintendent Fowler stated field 5's goals are mounted into the ground. Administrator Roth stated we will work on this. Administrator Roth did think the seasonal agreements should come to the Park Board. Demand for the fields is a good thing. Susan Thomas asked about amending the application who want to use the concession stand, would they be impacted by those who are using it with storage, and it was decided it would. This will be tabled.

- b. ADAM's Garden irrigation project

City Administrator Roth stated there has never been a written agreement between the city and the group. We have recently had those discussions. There is a need for the irrigations system to be improved. Superintendent Fowler has submitted a bid for consideration. He could only get one bid because they are all short-handed. This bid submitted went over the system, and half is working and half is not. He suggested do the half that is not working and the side that works leave it alone. The bid is \$5,836 for that. There was someone else who was going to bid, and he suggested the same thing, but he has not submitted yet. The current system was put in by volunteers. Kali Keenum asked about the funding for this. Administrator Roth stated there is \$ 19,000 in the ADAM's garden fund, which is generated through donations. In discussing with the group, we spoke about using these funds for improvements. This exact bid has not been shared with them yet. They would like to continue to maintain the landscaping, but the facility part the city should maintain. This is why we need a written agreement. We would like to move forward. President Schaecher stated by ordinance, three bids are required. Alderman Cleeve stated if they didn't respond, he would just submit what they have received. Alderman Cleeve asked that Chris put something in writing to show that the due diligence was done. President Schaecher stated he was comfortable with a motion not to exceed this dollar amount, if Chris receives other bids and they are more than this, then he can move forward.

Motion made by Kali Keenum, seconded by Susan Thomas, to accept the bid from West County Irrigation, in a not to exceed \$ 5,900 for the irrigation system to be paid from the ADAM's garden fund, pending receiving other bids with better pricing.

c. City clean-up day, June 16

Administrator Roth stated this was for information only. The intent is for the city to focus on certain areas for our own purposes. He asked if there was any particular project, we could try to do with city staff or volunteers. President Schaecher stated he has put out Pacific to the scouts for a service project. In scouting for higher level ranks, they have to have hours conservation minded. The back of the city park, honey suckle clean up, debris etc. They also spoke about the disk golf course that could be on the other side of the creek. Superintendent Fowler thought the first phase of the disk golf, was in the open area. The trails could be opened up, but then they need maintained. Administrator Roth stated city crews would stay on city property.

Old Business

a. Pool update

Administrator Roth stated Ryan Cassidy, Westport Pools gave a presentation last Tuesday to the Board of Aldermen. There is an ordinance to place the proposal on the August 8th ballot. It was given a first reading and then sent to the Administrative Committee. The presentation is on the u-tube channel. He has been pleased with their work. He thought we were in a good spot to present the plan to the community. President Schaecher stated during that presentation the video was skippy, but time jumped. Susan Thomas thought he did do a good job, and she was impressed, and it does have something for everyone in the community. Alderman Cleeve thought the best thing he saw was it looks much larger overhead and its staying contained in the existing pool area. We will have to have open house for feedback regarding options. Shade could be added if something else was taken away. Alderman Cleeve would like to have them sooner rather than later. Alderman Cleeve stated once approved the Park Board has to help decide how to pay for it every year. Susan Thomas stated there is no profit in this. President Schaecher reviewed the pool pass revenue funds. President Schaecher reviewed pool pass fees, and thought this should be looked at in the long term. Susan Thomas suggested focus meetings down at Red Cedar, if it is open at that time. Superintendent Fowler stated he has started filling the pool.

b. FY24 budget review

Administrator Roth reviewed the draft budget for fiscal year 2024. This was sent out prior. He continued there were a few changes from last month. The mayor directed him to increase the transfer, and thought it was necessary to fund the operations. We are proposing to remove the rodeo from the park fund and move to tourism. We have a rodeo fund generated from the rodeo funds, which is \$ 75,000, the intent is the rodeo should sustain itself going forward for general rodeo purposes. The impact to the park board is neutral generally. President Schaecher stated there is still labor cost. Superintendent Fowler thought most of it was normal preparation for the park, like dragging the arena, adding dirt etc. which is normal maintenance to him. Susan Thomas asked about any major impact regarding costs to repair, would that be expensed out of the Parks or would it be Tourism. Superintendent Fowler stated sometimes there is an expense for the panels. Administrator Roth agreed the intent would be to pay for panels out of the rodeo fund. Administrator Roth stated the capital improvements line for ADAM's garden was increased, for irrigation and small storage shed. This would come out of the ADAM's garden fund. Other line items were discussed in general. This budget is pushed to the limit and we need to be cautious of the timing of the spending. Administrator Roth stated

PW Commissioner Brueggemann has been working on the Hawthorne Pond but it has spending for it out of stormwater. He has quotes for draining it and also dredging it he thought. Improvements to the pond would come out of stormwater. President Schaecher thought that property was moved out of Parks anyways. ***Motion made by Susan Thomas, seconded by Kali Keenum to approve the Park Board Budget as submitted. A voice vote was taken with an affirmative result. Opposed: none. Abstain: none.***

c. Park property inventory

Administrator Roth stated there was no specific action needed. President Schaecher thought the Bigfoot Plaza and Red Cedar Inn needed more discussion with the Board of Aldermen. The water well lots didn't think they could be used much for park property. Keeping south of Liberty Field open for hook ups could be a good use of that property. Administrator Roth stated that was not flood buyout property, except for one little parcel. This is property south of LK Duncan Drive. President Schaecher stated at the last meeting we discussed adding RV hookups at this area, for short term stays not for storage. There was discussion on what flood buyout property could be used for. Administrator Roth stated these properties could be forested, or have native grass, trails etc. President Schaecher stated north of Liberty Field and the Orleans St. lots there is a lift station there is a pile of junk that needs removed. Administrator Roth stated this station is being renovated. There was discussion about Bigfoot Plaza being a tourist attraction verses a park. Superintendent Fowler stated it did not take much maintenance of the grounds. Committee members agreed to leave it in Parks. There was discussion about Red Cedar being in the Parks Department. There was further discussion if it would be eligible for grants if it was not considered in the Parks Department. President Schaecher recommended everything on the top half of the list other than Red Cedar and Hawthorne we request this be officially considered as part of the Parks Department. ***Motion made by Kali Keenum, seconded by Susan Thomas that everything on the top half of the list other than Red Cedar and Hawthorne we request this be officially considered as part of the Parks Department and submit to the Board of Aldermen.*** A voice vote was taken with an affirmative result. Opposed: none. Abstain: none. The other properties could be left for future discussion. He suggested in 2025 focusing on each individual park cleaned up.

Park Superintendent Report

Superintendent Fowler said the ballfields are done. One of the fields may need regraded. The dog park has everything on the small park, there is one feature missing on the large dog park. That feature is heavy and he needs help from Public Works. He is filling the pool tomorrow. The pool opens Saturday, May 27th. We do need a new city park entrance sign, he is still trying to obtain bids, but the quotes were \$ 7,000-\$8,000 so he may have to just work on replacing parts of it. There is electric to it, so one post has to stand. To replace it now as is, the cost is not as much.

Park Liaison Report – none. President Schaecher thanked Alderman Lesh for attending last time.

City Administrator Report - none

Miscellaneous -none. President Schaecher stated if anybody in the public needs anything please reach out. For Police Department items such as dumping or vandalism, please contact them.

Adjournment

Motion made by Susan Thomas, seconded by Kali Keenum to adjourn. A voice vote was taken with an affirmative result, and the motion carries. Meeting adjourned at 8:53 p.m.

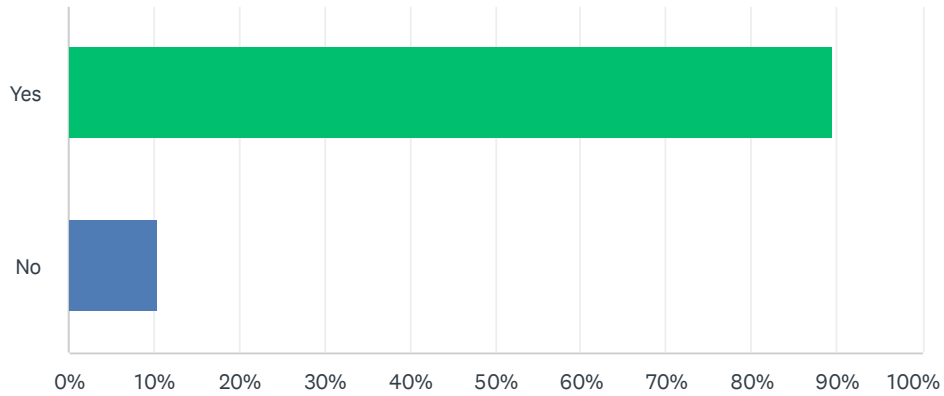

Q1 Are you registered to vote in the City of Pacific?

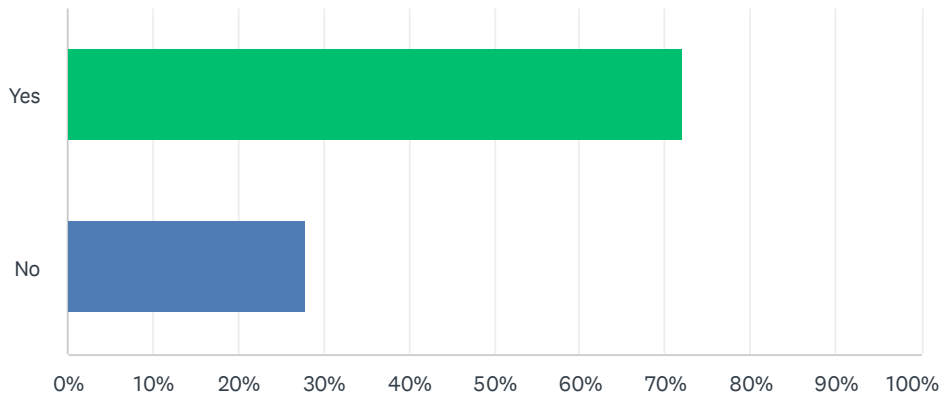

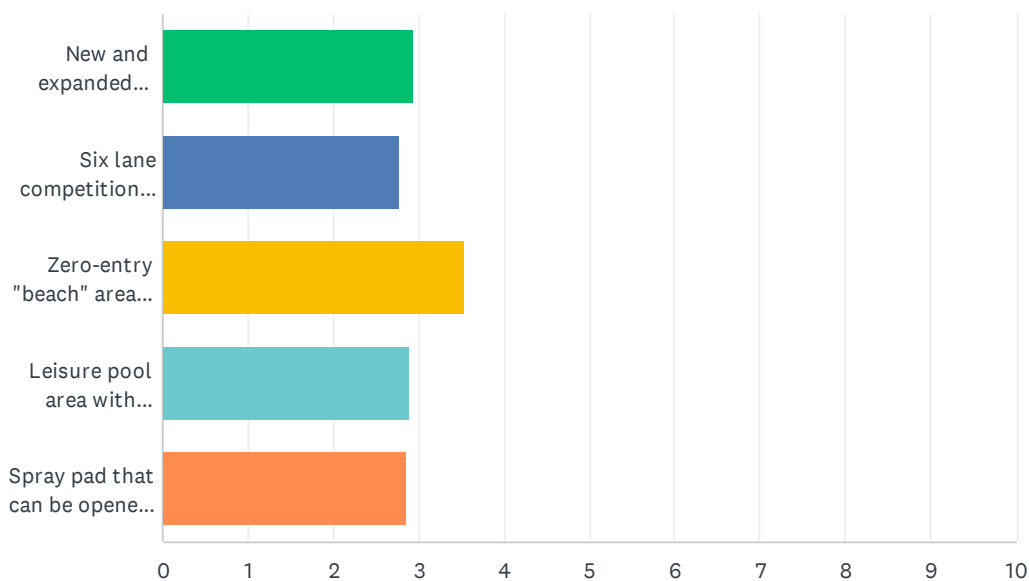

Q3 Which of the following pool features are most important to you?

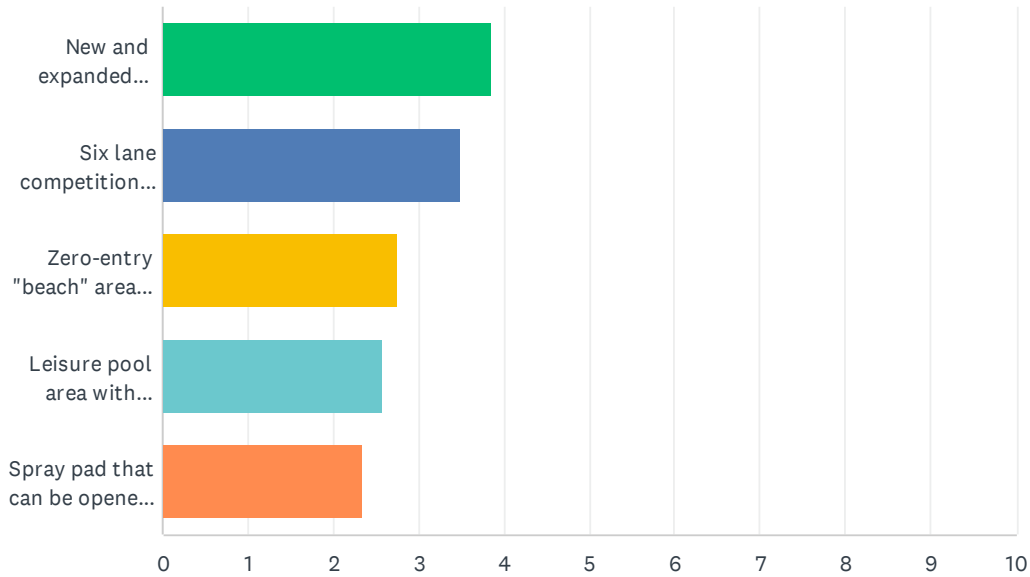

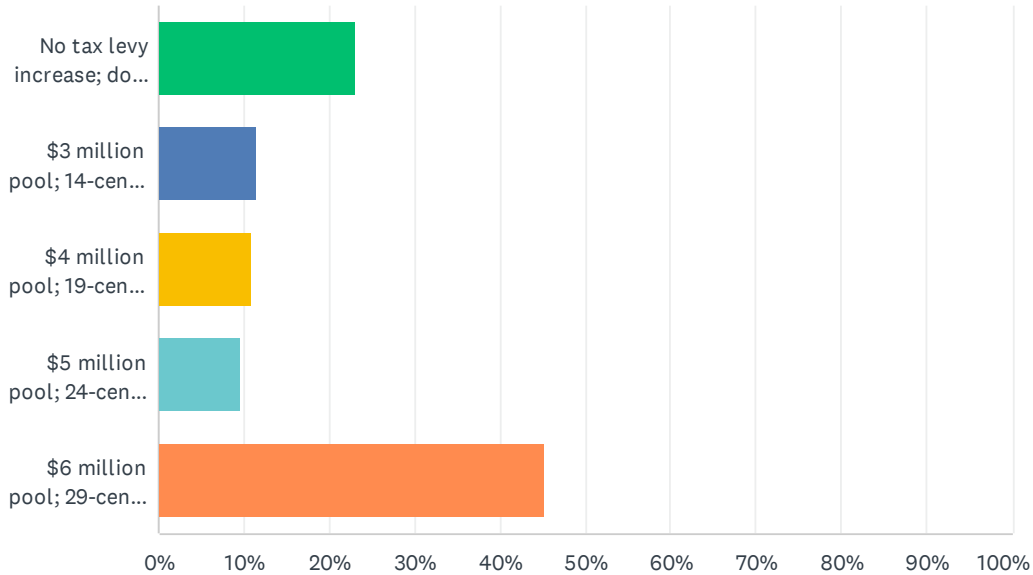

Dear Steve Roth:

The Missouri Department of Natural Resources and the Land and Water Conservation Fund review committee have completed the evaluation of the Fiscal Year 2023 Land and Water Conservation Fund grant applications. Fifty-one applications were received with the total amount of funding requested at approximately \$12.5 million. Ten projects were recommend for funding to the National Park Service totaling approximately \$2.6 million in grant assistance. Unfortunately, the City of Pacific was not selected to receive funding.

We greatly appreciate the time you took to complete your application and your interest in the Land and Water Conservation Fund. We hope that you will consider re-applying during the 2024 grant round. The 2024 LWCF grant round will be opening in mid-August. You can download the Fiscal Year 2024 Application and Open Project Selection Process (OPSP) Guide after August 17 at our website at: <https://mostateparks.com/page/61215/land-and-water-conservation-fund-lwcf-grants>.

To assist you in the application process, we wanted to provide you the following feedback from the committee regarding your 2023 application. The LWCF 2024 application will look similar to the last application with some changes to the project development and environmental review sections. The committee indicated that the application had good community support, but has made the following suggestions to help improve the application:

- 1) Include a copy of all the supporting documents listed on page 16 of the application. The 2024 OPSP will have details about how to get the environmental maps and reports.
- 2) LWCF Boundary Map - The LWCF boundary should include the entire park, not just the project area. Make sure to mark any utility easements on the boundary map.
- 3) Scope of Work (question #59) – This questions should focus on what is being constructed as a part of this application. The “why” for the construction can be moved to others questions within the application. Make sure that everything in the scope of work is also included in the budget narrative (question #75), and vice versa.
- 4) Master Plan (question #63) – Explain why the City decided to construct the skate park vs other amenities in the master plan that ranked higher.

- 5) Partnerships (question #67) – Donation of event space and the cost to host a fundraising event are not eligible to be used as match for the LWCF grant. The funds raised at the event are eligible to be used as match.
- 6) Budget Details (question #68-75) – Has the City already hired American Ramp Company (ARC) to construct the project? ARC is listed as the builders on the Floodplain Development Permit. Contractors cannot be preselected because the City will be required to follow federal and state procurement procedures.
- 7) Budget Table and Narrative – The donation column total should match the total from the Partnerships List (question #67). The budget narrative should be broken down by the cost categories of the budget table. See the sample budget narrative in the 2024 OPSP. Make sure that the totals in the narrative equal the totals on the table. Make sure that everything listed in the narrative (question #75), is also included in the scope of work (question #59), such as the pavilion. Contingency is not an eligible line item expense, so add the contingency into the line item cost under the construction cost category.
- 8) Question #83 – Has a Phase I Cultural Resource Survey been conducted in the last 3 years within the project area. If the answer is no, describe the construction plans including surface area depth and required fill.
